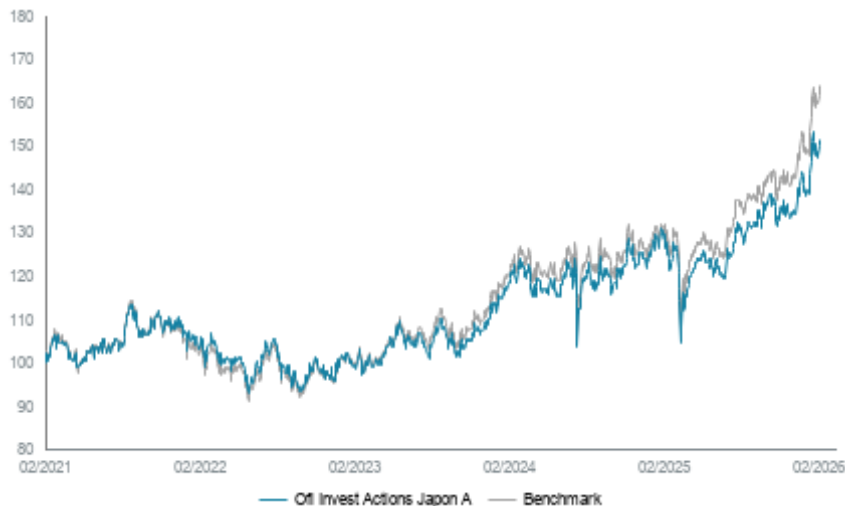

Investment commentary

Within the cavernous assembly halls of the Takasago plant, the overhead cranes of Mitsubishi Heavy Industries have not performed such a ballet in decades. This month, the conglomerate passed a symbolic milestone by shipping a new batch of its massive, state-of-the-art gas turbines—destined not for traditional factories, but to power the electricity-devouring behemoths that North American data centers have become. The old titan of Japanese heavy industry has transformed, almost unwittingly, into an indispensable supplier for the global artificial intelligence gold rush. This frenzy has propelled order books to dizzying heights this February. Faced with the insatiable urgency of American power demand, management has upgraded its annual operating profit forecast, now targeting the 350-billion-yen threshold. This unexpected renaissance illustrates the new grammar of Japanese capitalism in the face of the global tech shock. While attention has so far focused on the semiconductor fabs sprouting up across the country, markets are suddenly realizing that no generative algorithm can run without absolutely foolproof power generation and cooling infrastructure. Mitsubishi Heavy embodies this resounding revenge of hardware over pure software, finally reaping the rewards of a decade of painful streamlining to position its thermal engineering at the very core of the digital reactor. These dizzying heights now impose a ruthless standard of execution on the current backlog. Observers' attention will henceforth be fixated on the actual capacity of the archipelago's subcontracting network to keep pace with this brutal acceleration without choking their own supply chains.

Glossary

ALPHA	Alpha is equal to the average return on the product, i.e. the value added by the manager after deducting market influences over which the manager has no control. This calculation is expressed as a percentage.	BETA	Beta is an indicator of a fund's sensitivity relative to its benchmark. SRI	The SRI (Synthetic Risk Indicator) provides an assessment of the product's risk relative to that of other products. It indicates the probability of the product incurring losses in the event of market movements or of us not being able to pay you. SIX FINANCIAL STAR RATING	The rating is based on the analysis of the return and risk of each fund within its Europe performance category, using a minimum three-year track record. A score is calculated by comparing the fund's performance and volatility with those of its category index, and then converted into a number of stars according to a quintile ranking. A "junior" rating is applied to funds with a two- to three-year history, by linking their performance to their category index to reach the required three years.
