## ▶ Investment commentary

The fund gained 3.35% in April. Industrial metals continued to perform well despite the protracted conflict in the Middle East, the ongoing closure of the Strait of Hormuz and growing concerns over the potential impacts of this situation on economic activity. The market now seems to be focusing on production constraints stemming from the closure of the Strait of Hormuz. In addition to oil, the region supplies nearly a quarter of the world's sulphur, which is essential for refining certain metals. For example, it takes 10 tonnes of sulphuric acid to produce 1 tonne of nickel. Indonesia, the world's leading nickel producer, imports around 75% of its sulphur from the Middle East. Supply constraints on sulphur have been exacerbated in recent weeks by the decision by China and a number of other countries to restrict exports of this raw material. This situation could result in a sharp decline in the supply of nickel.

In addition, Indonesia has announced that it wants more control over its production. The country has invested heavily in nickel mining, growing its share of global production from 7% in 2015 to 64% in 2025. With supply outpacing demand in the short term, the government is keen to rebalance the market by lowering the limit on how much nickel each mining company is allowed to produce, restricting exports and setting a floor price for producers. Nickel was thus the top contributor to performance in April, gaining more than 13% over the period.

Copper and zinc are also affected by the availability of sulphuric acid, albeit to a lesser extent: around 15% of copper is refined by leaching, a process that requires sulphur. Specialists estimate that a lasting conflict could affect up to 5% of the annual supply of copper. This is in addition to the mounting production difficulties faced by mining companies: Ivanhoe Mines has notably cut its estimated production from the Kamoanga mine (DRC) by 90,000 tonnes in 2026 and 120,000 tonnes in 2027. Chile also reported a sharp drop in copper production in the early part of the year, which, if this weakness were to continue, would result in annual production of 4.7 million tonnes, compared with a market expectation of 5.2 million tonnes. Copper gained 5.5% in April and zinc nearly 4%.

Meanwhile, despite being the metal most affected by the war in the Middle East, aluminium gained very little in the month (up 0.3%). Yet the news on aluminium production is alarming: the Middle East refines around 9% of the world's aluminium, and the region's largest refinery, Al Taweelah, was hit by strikes, rendering it unusable. Experts estimate that, even if the Strait of Hormuz were to reopen soon, it would likely take 6 to 12 months for production to recover. The result is thus a considerable lasting reduction in supply in this market. The market nevertheless paused for breath in April after rising sharply in March; the accumulation of significant reserves of aluminium in China, as well as the potential impacts of the war on final demand, may have helped moderate the rise in prices.

Semi-precious metals were in wait-and-see mode, with platinum and palladium rising slightly, while silver lost almost 2% due to its correlation with gold, affected by rising interest rates.

The impact of the situation in the Middle East is complex: the market now seems to want to remain optimistic that the conflict will be swiftly resolved and the Strait of Hormuz reopened. However, if the Strait were to remain closed for a prolonged period, this could end up affecting activity through higher oil prices or restrictions on use. This scenario encourages a measured approach to risk. Conversely, sharp declines in metal production have a big positive impact on some markets, and a prolonged conflict would only amplify the supply shock. In the longer term, we believe this new energy shock paves the way for a faster energy transition, as already suggested by the surge in demand for electric vehicles and solar panels. That being the case, the promising trend in strategic metals could just be getting started.
