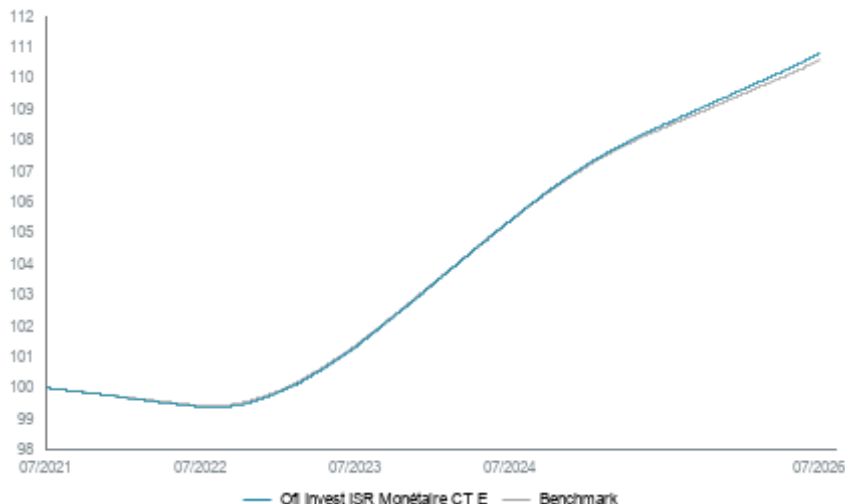

Investment commentary

Equity markets delivered mixed performances in July, reflecting the rebound in oil prices driven by persistent tensions in the Middle East and renewed concerns over the valuations of artificial intelligence (AI) specialists, particularly semiconductor manufacturers.

In fixed income markets, bond yields moved higher as the recovery in oil prices fuelled inflationary concerns and reinforced expectations that the major central banks may maintain restrictive monetary policies for longer than previously anticipated. Yields rose in both the United States and Europe, as the oil price rebound linked to the Middle East conflict heightened inflation risks.

Against this backdrop, the Federal Reserve left interest rates unchanged. However, its new Chair, Kevin Warsh, adopted a distinctly hawkish stance, reaffirming that the central bank would not hesitate to act should inflationary pressures intensify. This outlook, despite inflation having eased in July, pushed long-term US Treasury yields to their highest levels in nearly twenty years. The yield on the 10-year US Treasury note increased by 27 basis points to 4.73%.

Government bond yields also moved higher across Europe in July. As in the United States, fixed income markets were affected by the continued surge in oil prices stemming from geopolitical tensions, which reinforced inflationary risks. The European Central Bank (ECB) decided to leave its key interest rates unchanged, allowing itself additional time to assess the impact of renewed tensions in the Middle East and the sharp rise in oil prices on inflation within the monetary union. The ECB's next monetary policy meeting is scheduled for 9 and 10 September.

The yield on the German Bund rose by 35 basis points in July to 3.21%. In France, the yield on the 10-year OAT (Obligation Assimilable du Trésor) increased by 35 basis points to 4.00%. For the first time since September 2008, the yield on the French 10-year government bond exceeded the 4% threshold. Elsewhere in Europe, the yield on Italian government debt rose by 39 basis points to 4.02%.

The 3-month Euribor stood at 2.484%, while the €STR (Euro Short-Term Rate) was 2.184%.

Glossary

ALPHA	Alpha is equal to the average return on the product, i.e. the value added by the manager after deducting market influences over which the manager has no control. This calculation is expressed as a percentage.	BETA	Beta is an indicator of a fund's sensitivity relative to its benchmark. A fund with a beta of less than 1 is likely to fall less than its benchmark, while a fund with a beta of greater than 1 is likely to fall further than its benchmark.	RECOVERY PERIOD	The recovery period (expressed in days) is the number of days needed to recoup the losses incurred after a maximum loss is sustained. Maximum loss is the largest loss the fund has experienced.
