## Ofi Invest Asset Management steps up its commitment to biodiversity by publishing its biocides policy

Ofi Invest Asset Management announces that it is publishing its policy on biocides and dangerous chemicals as part of its overall biodiversity strategy. The policy will come into effect on 1<sup>st</sup> January 2024 and be revised each year thereafter.

"Ofi Invest Asset Management intends to take action towards protecting biodiversity more effectively and we have therefore added a new component to our commitment to preserving and protecting nature; this component seeks to tackle the pollution and harm to species caused by biocides, neonicotinoids and other dangerous chemicals as well as the damage to the environment and health for which these substances are responsible", explains Eric Bertrand, Chief Investment Officer at Ofi Invest Asset Management.

Our policy consists of exclusions targeting biocide and neonicotinoid producers. We will also be launching awareness campaigns and engaging in dialogue with the main biocide suppliers and with other companies involved in major controversies due to the environmental and health impact caused by the manufacture, use and discharge of dangerous or toxic chemicals or substances.



As Aéma Groupe's asset management entity, Ofi Invest AM manages a number of investment mandates on behalf of MACIF and Abeille Assurances to which this policy will apply as from 1<sup>st</sup> January 2024.

Ofi Invest Asset Management had already adopted a first policy, applicable to palm oil, on 1<sup>st</sup> January 2023.

This new policy reinforces Ofi Invest Asset Management's pledge to protect our planet's natural capital and tackle biodiversity loss. This commitment also takes the shape of:

- Collaborative work with financial market bodies such as CDC Biodiversité and Club B4B+;
- Membership of initiatives such as the Finance for Biodiversity Pledge, the Sustainable Blue Economy Finance Principles and the Nature Action 100 coalition, of which Ofi Invest AM was a founding member in 2023;
- Engagement action on the themes of plastic, palm oil and animal proteins;
- Efforts to address biodiversity-related issues by assigning ESG (Environment, Social and Governance) ratings, monitoring controversies and carrying out research into innovative solutions that have a positive impact on nature.
